Dear Mr. Aguero:

As we have discussed, Hunton Andrews Kurth LLP (formerly known as Andrews Kurth Kenyon LLP) and the Clark County Stadium Authority (the “Authority”) desire to amend the January 18, 2017 Engagement Letter (as amended on March 28, 2018, on May 23, 2019, and on May 21, 2020, the “Letter”) entered into between the parties to expand the scope of services and compensation referenced in the Letter.

Scope of Engagement. The Letter is hereby amended by expanding the Scope of Engagement referenced in the Letter to provide that from and after July 1, 2021, and for a period ending on June 30, 2022, Hunton Andrews Kurth LLP (“HAK”) and Brownstein Hyatt Farber Schreck LLP (“Brownstein”) will continue to represent the Authority’s interests in regard to the construction and operating phases of the premier stadium facility in Las Vegas known as Allegiant Stadium.

Staffing and Fees. We will bill you for our services based on the hourly rates of the attorneys as set forth in Exhibit A attached hereto. We will notify you should additional attorneys, other than those listed on Exhibit A, be required for a specific matter and we will provide you information concerning the billing rates of such additional attorneys.

All other provisions set forth in the Letter shall continue to apply.
